## Addendum to Meeting Minutes

- Final vote count to Transgender Athlete participation policy:
  - 1. The ISWGA Board voted earlier this summer to allow transgender athletes to participate in the ISWGA event in an "Open Division". Individuals in that Open Division will compete only against those in that division for prizes.
